**Anna Costanza Baldry** is full professor at the Department of Psychology of the Università degli Studi della Campania Luigi Vanvitelli. She has been collaborating for over 20 years with NGOs and addressing risk assessment, femicide, orphans of femicide. She has published approximately 100 articles in prestigious national and international scientific journals, book chapters and monographs, as well as presented her work at numerous national and international conferences. She has coordinated several prestigious projects with special emphasis on women victims of violence. She was an active member of the Cost Action IS1206 'Femicide across Europe'. She is visiting scholar at the Institute of Criminology, Faculty of Law, University of Cambridge.



**Chaime Marcuello Servós** is a lecturer in Social Work and Social Services in the Department of Psychology and Sociology at the University of Zaragoza; a professor on the Inter-Doctoral Programme in Science and Humanities for Interdisciplinary Development at the CEICH of the UNAM and the UAdeC (Mexico). In addition, he is Coordinator of the Interdisciplinary Teaching Innovation Group (GIDID); co-founder of the Third Sector Social and Economic Studies Group (GESES). He is President of the RC51 on Sociocybernetics (2014-2018) of ISA. He is Editor of Current Sociology Monographs and SISS Books (2016-2019) and co-director of the Iberoamerican

Journal of Development Studies.



**Christiana Kouta** is an Associate Professor at the Department of Nursing. She is the Head of the Master in Advance Nursing and Community Health and Care. She is teaching Community Nursing, Health Promotion, Transcultural Nursing, Family Nursing. Dr. Kouta's research combines community and transcultural health related to culture and gender. Currently she is leading an EU funded project on knowledge platform for FGM. She is involved in other EU projects related to Cultural Competent and Compassionate Health Care. She is the scientific coordinator in the COST Action Femicide across Europe and the Secretary of the European Transcultural Nurses Association.



**Consuelo Corradi** is professor of sociology and Vice-Chair for research and international relations at Lumsa University, Rome, Italy. She served as co-Chair of the Cost Action IS1206 on Femicide across Europe. Her research interests include violence against women, femicide, and more recently the cross-national comparison of gender policy regimes across Europe. Her most recent book is "The concept and measurement of violence against women and men" (Policy Press, 2017), co-authored with S. Walby, J. Towers, S. Balderston and others. Consuelo was Vice-President of European Sociological Association from 2007 to 2009.



**Ksenia Meshkova** comes from St. Petersburg, Russia and lives in Germany since 2007. She is a graduate of St. Petersburg State University, Tartu University and Erfurt University. She is currently writing her PhD thesis titled „Intimate Partner Violence in Modern Russia“ at the Humboldt University in Berlin. Her studies have been sponsored by the German Academic Exchange Service and Friedrich Ebert Foundation. Ksenia is an active member and young scholars' day organizer of European Network on Gender Violence. Currently Ksenia is

coordinating the 10<sup>th</sup> European Feminist Research Conference in Göttingen and teaching at the Protestant University of Applied Sciences in Berlin.



**Maria José Magalhães** is Full Professor at FPCEUP, researcher member of CIEG and CIIE. She is the recipient of the Award Carolina Michaelis de Vasconcelos – Research on Women’s Studies/1990. Her current main field of research is on gender violence and femicide, where she is a member and coordinator of several research projects. Currently, she is the Leader of the transnational Project “Bystanders: developing bystanders responses among young people”, funded by EU REC Programme. She was also the Principal Investigator (Portugal) of the transnational Project CEINAV, funded by HERA-ESF (2013-2016). MC member of the COST – Femicide Across Europe (2013-2017) and scientific Coordinator of the Observatory of Women Murdered, OMA-UMAR (2004-2010).



**Monika Schroettle** is Professor at the Technical University of Dortmund, Germany, and is leading research projects for the Institute for Empirical Sociological Research at the University of Erlangen-Nürnberg, Germany. She is an expert in violence against women, quantitative violence prevalence research, disability studies, violence and ethnicity and in empirical human rights research. She is also a coordinator of the European Network on Gender and Violence ([www.engv.org](http://www.engv.org)), a research network of more than 400 researchers. Furthermore, she has been coordinating several international working groups on data collection and monitoring of gender based violence in European research networks (e.g. for the COST Action on Femicide and the Coordination Action on Human Rights Violations / CAHRV). In her last project she developed a “Measurement framework on violence against women” to be integrated in the Gender Equality Index for the European Institute for Gender Equality (EIGE). Schröttle is also country expert of the Academic Network of European Disability Experts (ANED) and prepares national reports on the state of disability policies and the situation of disabled people.



**Santiago Boira Sarto** graduated in psychology from the University of Salamanca (Spain) and received his Ph.D. from the University of Zaragoza (Spain). He is currently a Lecturer in the Department of Psychology and Sociology and coordinator of the Master's degree in gender relations at the University of Zaragoza. His research interests focus on gender issues, intimate partner violence, especially in men abusers. He is also a researcher of the Group of Social and Economic Studies of the Third Sector (GESES). He was a member of the network Femicide Across Europe, Cost Action IS-1206.



**Shalva Weil** is Senior Researcher at the Hebrew University of Jerusalem, Israel. From 2013-7, she served as Chair of the Cost Action IS1206 on “Femicide Across Europe,” heading a management committee of 80 people representing 30 countries. She has addressed the Parliaments of Portugal, Aragon (Spain) and Rome, and spoken at three UN meetings on femicide in Bangkok, New York and Vienna. She has published over 100 journal articles, including 11 in scientific journals on femicide, and edited Special Issues on Femicide and several books on Indian Jews, Ethiopian Jews and other topics. In 2016, Shalva Weil published an article in *Qualitative Sociology Review* on “Failed Femicides among Migrant Survivors.” She has contributed to the ACUNS volumes *Femicide* 3, 4, 6 and 8, where she wrote about the COST network, femicide of girls in India and femicide of elderly women in Israel. She is co-editor (with Chaime Marcuello, Consuelo Corradi and Santiago Boira) of a Special Issue on “Femicide: a Social Challenge” in *Current Sociology* (2016), where she also published a single-authored article “Making Femicide Visible”. She is also co-editor (with

Christiana Kouta) of a Special Issue on “Researching Femicide from a Qualitative Perspective” in *Qualitative Sociology Review* (2017). She is currently co-editing (with Consuelo Corradi and Marceline Naudi) the first book on “Femicide in Europe” with Policy Press. In the applied field, she runs an empowerment program for slum migrant women of Caucasian origin in Israel. She has worked among Ethiopian immigrants and researched intimate partner femicide among them in Israel.

**Marceline Naudi** (B.A.,M.A.(Bradford),Ph.D.(Manchester)) is the Scientific Coordinator of the European Observatory on Femicide (EOF). Marceline is a social worker by profession and a Senior Lecturer within the Department of Gender Studies, at the University of Malta. She contributes to teaching and supervision of student research on gender issues, violence against women and other anti-oppressive issues at Diploma, Bachelor, Master and Doctoral level. She continues to be active on the issues of gender equality and violence against women, LGBTIQ, as well as wider human rights issues, both locally in Malta and in Europe. She is also a board member of the Women Against Violence Europe (WAVE) network, and vice president of GREVIO, the Council of Europe monitoring body of the Istanbul Convention. She is currently Regional Editor of the Journal on Gender Based Violence, and is co-editing a special issue, and she is leading EU funded research projects in Malta on the Bystanders Approach to Sexual Harassment, and on Barriers to Reporting for victims of Violence against Women.
